


# Show off your Solution 2006 World Finals!!

## How to "make the cut"

-  Choose **10 seconds to 2 minutes** of your best competition footage and copy to a DVD or CD.
-  Please follow these guidelines for ease of compilation:
  1. The preferred resolution of the video must be **no bigger** than 720 x 576 pixels and **no smaller** than 320 x 240 pixels.
  2. The files should have extensions : MPEG, MPG, AVI or VOB. Please no Real Player, Quick Time, or WMV formats.
-  Fill out both Video Release Forms included in this packet. **Remember: Only videos accompanied by a Video Release Form will be considered.**
-  There are two ways to submit your video:

  2. Bring the video clip and the Video Release Form to World Finals Registration when you check in.
-  The earlier we get your footage, the better the chances we will air it. If you mail your video and forms, they **must arrive before May 7.**  
(Video clips will not be returned.)
-  Also — **bring your World Finals competition footage**, along with signed release forms, to the PR Center during World Finals. The same guidelines apply.
